Location: Designated viewing area in Parade Ring Public Enclosure, Sha Tin Racecourse (The audience entrance for “Edan@MIRROR’s Live Performance” will be located on the Sha Tin Racecourse Concourse)

1. Successful registrants should present the confirmation SMS for admission to Sha Tin Racecourse via the Public Enclosure, and experience the exciting activities on 2024/25 Racing Season Opening Day.
2. From 4:00pm to 5:45pm on 8 September, please go to the designated counter on the Sha Tin Racecourse Concourse to present the registration confirmation SMS and redeem a designated wristband for entry to “Edan@MIRROR’s Live Performance” in the Parade Ring public designated viewing area.

Remarks:

- The audience entrance for “Edan@MIRROR’s Live Performance” will be located on the Sha Tin Racecourse Concourse.
- The last admission time is 6:00pm on that day.
- Terms and conditions apply.
- The audience entrance for “Edan@MIRROR’s Live Performance” will be located on the Sha Tin Racecourse Concourse, please follow the instructions from HKJC staff for entry.
- The event details may be subject to change without prior notice. The Hong Kong Jockey Club reserves the sole and all right to make decisions relating to the activity at any time without notice. In case of any dispute, the decision of The Hong Kong Jockey Club shall be final.
- “Edan@MIRROR’s Live Performance” will be held at Sha Tin Racecourse Parade Ring at approximately 6:15 pm.
- Racecourse entrants must be aged 18 or above.
- Special crowd safety management measures will be implemented at the Racecourse. Please follow the guidance from HKJC staff.
- For safety reasons, no overnight queuing will be facilitated.

- After Race 7 (around 4 pm), individuals will be gradually invited to leave the Parade Ring public designated viewing area. Please follow the guidance from HKJC staff and leave the Parade Ring in an orderly manner.
- From Race 7 onwards, only individuals with valid wristbands may enter the Parade Ring public designated viewing area. Quota is 750 and available on first-come-first-served basis.
- Seating at the Parade Ring Member's Enclosure are limited and will operate on a first come, first served basis. Occupying or reserving seats for others is strictly prohibited.
- Unattended objects at the designated viewing area will be handled according to HKJC lost property procedures.
- If the Parade Ring viewing area is full, no further access will be allowed. Individuals may enjoy the performance through the big screen at the outdoor Forecourt area.
- Standing on staircases during the performance is prohibited.
- No tripods, folding stools, ladders or other articles that may pose safety hazards are allowed in the Racecourse.
- No admission to the Member's Enclosure is allowed aside from HKJC Members, staff and officials, or individuals with valid badges.
- Please follow the guidance of HKJC staff and leave the Parade Ring in an orderly manner after the Performance has ended.

Terms & Conditions:

1. No change or cancellation of registration is allowed once the booking is confirmed.
2. Successful registrants must redeem the wristband(s) in person between 4:00pm to 5:45pm on 8 September at the designated counter on the Sha Tin Racecourse Concourse. Quota will be forfeited without notice if the registrant failure to redeem during the mentioned timeslot.
3. The registration quota and wristband are not for resale purposes whether with the intent to make profit or not and cannot be exchanged for cash.
4. Entrants must take care of and be responsible for his/her own personal belongings and safety. To the maximum extent permitted by laws of Hong Kong, The Hong Kong Jockey Club will neither be responsible for the loss or damage to any property nor any injury or death sustained by entrants.
