Terms & Conditions (Public)

1. By participating in the questionnaire (“**Questionnaire**”) and/or the lucky draw (“**Lucky Draw**”), you are deemed to have understood, accepted and agreed with all of the terms and conditions set out below and undertake to comply with all applicable laws and regulations in the course of participating in this Questionnaire and this Lucky Draw. To participate in this Questionnaire and this Lucky Draw, participant(s) shall fill in the online form on the designated website of The Hong Kong Jockey Club (the “Club”) and submit the completed form, and the participant shall bear his/her own costs for or in connection with the participation in this Questionnaire, Lucky Draw and/or any related matters.
2. All participants must be at least 18 years of age and hold valid Identity Card or travel document. All participants must provide a valid mobile number (for the purpose including but not limited to prize notification), their full name in English as it appears on their Identity Card or travel document, and alphabet and the first three digits of their Hong Kong Identity Card (or the last four digits/ alphabets of their travel document, if applicable) in order to enter the Lucky Draw. Prize winners must present their valid Identity Card or travel document for verification when collecting their prizes. In these terms and conditions, 'The Club' refers to The Hong Kong Jockey Club.
